Asian American Power Table Gets Out the Vote



The Asian American Power Table joined forces with APIA Vote to host the Norman Y. Mineta Leadership Institute Training. The training provided an overview on how Asian Americans Pacific Islanders (AAPI) are shaping the national scene, as well as touching on issues that are pertinent to the communities in Philadelphia. On March 31st the members of the Asian American Power—PCDC, Asian Americans United (AAU), SEAMAAC, Pennsylvania Immigration and Citizenship Coalition (PICC), and VietLead—taught volunteers how to register people to vote, utilize mobilization strategies, and impart skills for canvassing/phone banking.

In another event PCDC, AAU, SEAMAAC, and VietLead collaborated on canvassing Asian American communities in Northeast Philadelphia on April 29th. Over 30 volunteers worked together to survey community members regarding immigration issues.

Finally, in early May, the Asian American Power Table held multiple phone banking sessions. Over



50 volunteers attempted 15,000 phone calls during this four day marathon. Volunteers contacted Asian Americans throughout the entire of state of Pennsylvania to remind them to vote and canvass them regarding immigration issues.

PCDC Volunteers Receive Citations for Voter Registration Work!

On Saturday, May 19th, PCDC volunteers: Danny Le, Ana Canchola, Boni Zhang, Sovichea Hout, and Jinlong Zhang, received citations from Councilman David Oh for their volunteer work. Volunteers worked with Councilman David Oh's office to do a non-partisan voter registration drive in May 2017.

Notice to the Community

Chinatown is looking very clean thanks to the \$1-a-Day street sweeping team, as well as various community cleanups that PCDC has hosted this past month, including the 2018 Chinatown Spring Cleanup and Comcast Cares Day. Hundreds of volunteers dedicated hours to making sure that our community is walkable, pleasant, and litter free. However, despite all of the effort and resources that go into Chinatown, some areas continue to face constant illegal dumping and sewage runoff.

"The 1000 block of Appletree Street needs serious attention and care from neighborhood residents and business owners," says PCDC executive director John Chin. The daily volume of trash and illegal dumping has been challenging for PCDC's \$1-a-day street sweepers. No amount of sweeping and cleaning has been able to keep Appletree Street clean. Lamei Zhang, Main Street Manager, will work with business owners, residents, and City officials to try to solve the problem. In the meantime, here are a couple of tips that neighborhood elementary students want to share with adults:

#1. Please do not throw away your garbage onto the street; and #2. Do not litter.

The Sanitation Division provides weekly residential curbside trash collection. The resident is responsible for providing the collection containers; there are no City provided containers.

The more you know about the **DOs** and **DON'Ts** of trash collection and recycling and the collection schedule – the easier it is to do your part to keep our community clean. Here's a list of important information that can help:

- •Trash and Recycling Collection Day:
 - *Chinatown North (North of Vine Street): Mondays
 - *Chinatown South (South of Vine Street): Thursdays
- •Collection Schedule (When you should set out your trash and recycling)
 - *October 1 through March 31: Trash and recycling can be set out between 5:00 PM the night before and 7:00 AM the day of collection;
 - *April 1 to September 30: Trash and recycling can be set out between 7:00 PM the night before and 7:00 AM the day of collection.
- •What the city DOES NOT collect:
 - *Computers, monitors, televisions
 - *Bulk items, or items that contain significant amounts of metal and are too large to fit in a 32 gallon trash receptacle, such as refrigerators, stoves, washing machines, metal furniture, etc.

PHLCVB Drives City's Convention and Global Tourism

PCDC executive director John Chin attended the annual PHLCVB meeting and heard first-hand its success. "PHLCVB data showed that 2017 was a good year for hotels and the economy," said John Chin. "PCDC will work with local businesses to ensure that this trend translates to growth for Chinatown."

The Philadelphia Convention & Visitors Bureau (PHLCVB) is a nonprofit membership corporation which focuses on driving hotel occupancy for Philadelphia. Last year PHLCVB attracted over 800,000 attendees to Philadelphia; more than 75% of the attendees convened at the Pennsylvania Convention Center which abuts Chinatown. This translated to \$581 million in economic impact and supported 4,325 full-time equivalent jobs.

PHLCVB manages a global team, which promotes Philadelphia to overseas visitors by marketing and selling Philadelphia to tour operators and travel agents. This effort grew Philadelphia's share of overseas visitors, despite a 2% decline for the nation in 2016, and led to \$1 billion in economic impact. China was the fastest growing of Philadelphia's overseas markets. PCDC will work with businesses to capture this growing market segment .



An Intimate Conversation on Historic Preservation

PCDC hosted a meeting of 9 community members to conduct a small, nurturing and intimate conversation on historic preservation for Chinatown last month. The participants come from diverse backgrounds, which include old and new residents, business owners, a property manager, a retired architect, a first responder, and an educator. Together they shared many interesting narratives and valuable perspectives.

The meeting is part of the Historic Preservation Citizen Engagement project led by PennPraxis, which aims to develop, prototype, test and deploy a toolkit for convening community conversations around historic preservation across the city. PCDC served as the community liaison that invited residents for a community dinner and facilitated a lively 90 minute discussion. We learned that participants value both the physical and the ethnic and cultural aspects of preservation. Folks shared their fond memories of significant places and historic landmarks in Chinatown, such as the Friendship Arch, the House of Dragons Firehouse, venerable restaurants, etc. They also identified a lack of preservation activity in our neighborhood, while some expressed concerns over the conflict between large developments and preservation, as well as Philadelphia's current Historic District system.

Looking ahead, the community input will help us create a support network to share information and protect our heritage. The project is informed by, and will report to the Philadelphia Historic Preservation Task Force created by Mayor Jim Kenney. We hope that our collected voices will influence the future decision-making of Chinatown's preservation policies.

Frequently-Asked Questions About Health insurance

What is Medicare

Many people are confused about which is which. This will be the start of a series of articles to help clear up these misconceptions. **Medicare** is health insurance for people 65 years old and over. **Medicaid** is health insurance for people with low incomes. Some might be eligible for both.

To be eligible for Medicare, you MUST:

Be at least 65 years old

Be a U.S. citizen or permanent resident who has lived here in the USA for at least 5 consecutive years

*Have a qualifying disability if you are under 65 years old. You have to APPLY for Medicare, it does not automatically enroll you when you meet the criteria. They recommend starting 3-6 months before you turn 65 years old.

There are four parts to Medicare:

Part A (Hospital Insurance)

Part B (Medical Insurance

Part C (Medicare Advantage Plan)

Part D (Prescription Drug Coverage)

After an attendee visits a table, workshop, activity or completion of a survey they will earn a sticker which can be redeemed for a raffle ticket. Raffled prizes are donated by the organizations participating in the EXPO event. PCDC is looking forward to another successful event and hopes that it provides the community with a wealth of beneficial information.

PCDC Hosted Focus Group on **Financial Accessibility**

With the support from UnidosUS, National Urban League and National CAPACD, on Tuesday March 27, PCDC hosted a focus group to discuss financial behaviors and accessibility to financial products. The same focus groups were conducted in Chicago and San Diego in April. 11 community members attended this event and provided their valuable experience.

Hearing directly from members of the community helps to learn what works and doesn't for communities of color today, and the best ways we can address future needs. The finding of this focus group would be used to update the previous Banking in Color report that was released a few years ago. This report would be used to provide recommendations and best ideas to policy change.

LEP is a Barrier to Homeownership

The Urban Institute recently published the report below which states new evidence showing that limited English proficiency (LEP) is a barrier to homeownership:

"Owning a home remains the most reliable way for American families to build wealth and is often financially better than renting. But access to homeownership is not equal. Hispanic and black households have lower

> homeownership rates than non-Hispanic white households (46 percent and 41 percent versus 71 percent).

> Many factors contribute to this disparity, and understanding their impacts can be difficult. New research helps clarify one piece of this puzzle by establishing that limited English proficiency is a barrier to homeownership. Looking at data at the zip code level from the Urban Institute and Sloan Foundation's Administrative Data Research Facility, we found a considerable gap in homeownership rates between neighborhoods with low levels of limited English proficient (LEP) residents and those with higher levels of



LEP residents.

Neighborhoods with the lowest concentration of LEP residents had a median homeownership rate of 74 percent in 2016, but neighborhoods with the highest LEP concentration had only a 64 percent median rate—a 10 percentage-point difference. If we control for other factors that influence

> homeownership (e.g., income, age, and race), neighborhoods with the highest concentrations of LEP residents have homeownership rates 5 percentage points lower than rates in neighborhoods with the median concentration of LEP residents. Limited English proficiency has a considerable impact on homeownership rates.

Last October, the Federal Housing Finance Agency announced it would add a preferred language question to the redesigned Uniform Residential Loan Application. This new question will allow lenders and regulators to gather data to help them size the market of potential LEP homeowners and determine how they can best serve these populations. Our new findings suggest that the addition of a language variable on the loan application is a

move in the right direction.

Spanish-language speakers compose 62 percent of the LEP population, and 42 percent of Spanish speakers do not speak English "very well." Focusing on this group may be the best way to start addressing this problem, but we need to reduce all forms of limited English proficiency as a barrier to homeownership."

Limited English proficiency is a clear barrier to homeownership. PCDC is the only organization which offers aid to Chinese speaking community members in purchasing homes in Pennsylvania. Through homeownership education, mortgage counseling, financial literacy and outreach efforts, PCDC helps you build wealth and prepares families for homeownership. In addition to these workshops, PCDC offers individual pre-purchase, post-purchase, and rental counseling.

Philadelphia Fire Department Gets Grant for almost \$1 Million for Traditional and Adaptive Smoke Alarms

Back in 2017, the Philadelphia Fire Department got awarded the Smoke Alarm grant to help pay for smoke alarms for anyone who needs one. The smoke alarm grant comes from the Federal Emergency Management Agency through the Department of Homeland Security.

The funds will pay for about 26,000 traditional alarms and 4,000 adaptive alarms for residents who are deaf, hard of hearing, blind or have low vision. Adaptive alarms are designed to warn persons with hearing or vision loss about a possible fire. They come in multiple designs, including some that shake beds and others that activate strobe lights – and they can cost 10 times as much as traditional smoke alarms.

Need an alarm? Call 311



If you need a smoke alarm, please contact 311 and specify if you need an adaptive alarm. For traditional alarms, it could take 60 days from the date of the request until the alarms are installed. Smoke alarms should be located on each level of a home, including the basement. You should test them each week!. In cooperation with city and community partners, the Fire Department currently installs about 8,000 alarms per year, which translates into more than 2,600 addresses. Because of the new funding, they will be increasing the number of installations over the next two years.

Smoke Alarms Save Lives.

The risk of dying in a home fire is cut in half in homes with working smoke alarms.

Tips to prevent burglary for residents:

- 1. Cover your windows with curtains or blinds
- 2. Place your valuables out of sight
- 3. Install an alarm system
- 4. Keep your doors and windows locked
- 5. Avoid hiding your spare key

Tips to prevent burglary for business owners:

- 1. Get in touch with local law enforcement before a crime happens
- 2. Be aware of your surroundings and how you might be a target
- 3. Hire real, live security personnel
- 4. Stay up on the news, and get involved in the community
- 5. Make sure your alarm system notifies the police first, not you
- 6. Outfit your physical space with the proper security measures
- 7. Install security cameras; Commerce Department will provide grants.

費城消防部門獲得了一百萬美元的撥款用於 傳統型和自我調整型煙霧警報

2017年,費城消防部門得到煙霧警報撥款用於為有需要的 人群支付煙霧警報費用。 煙霧報警補助金通過國土安全 部來自聯邦緊急事務管理局。

這筆資金將支付約2.6萬個傳統警報和4,000個自我調整警報給失聰,聽力障礙,失明或視力低下的居民。自我調整警報旨在警告聽力或視力喪失者可能發生的火災。 他們有多種設計,包括一些搖床和其他啟動閃光燈的設計 - 而且這些設備的價格是傳統煙霧通報器的10倍。


有限的英語能力是對住房擁有權的障礙

Urban Institute最近發布了以下報告,其中指出新的證據表明,有限的英語能力是對住房擁有權的障礙:

"擁有房屋仍然是美國家庭建立財富的最可靠的方式,而且在

經濟上比租賃更好。但獲得住房擁有權並不平等。西班牙裔和黑人家庭的住房擁有率低於非西班牙裔白人家庭(46%和41%比71%)。造成這種差距的因素很多,理解它們的影響可能很困難。新的研究有助於澄清這一難題,即確定有限的英語水平是對住房擁有權的障礙。以郵政編碼劃分,Urban Institute和Sloan基金會行政數據研究機構的數據後,我們發現英語水平有限的(LEP)居民和LEP居民比例較低的居民區之間

的房屋擁有率差距很大。2016年LEP居民比例最低的那些居民區的平均住房擁有率為74%,但在LEP居民比例最高的那些居民區這一數字僅為64%-相差10個百分點。如果我們剔除影響房屋所有權的其他因素(例如收入,年齡和種族),那麼LEP居民比例最高的居民區的房屋擁有率將比LEP局民比例中等的居民區的房屋擁有率低5個百分點。這說明有限的英語水平對住房擁有率有相當大的影響。



我們不太確定有限的英語水平怎樣妨礙了住房擁有權的獲取,但這項研究表明,這一個障礙的嚴重程度重於其他的障礙。這一發現表明,我們可能會通過更好地服務於LEP推廣住房擁有權。 去年10月,聯邦住房金融機構宣布將在重新設計的統一住宅貸款申請表中增加詢問申請者首選語言的問題。這個新問題將允許貸款人和監管機構收集數據,幫助他們規劃潛在的LEP房主的市場,並確定他們如何能最好地服務於這些人群。我們的新發現表明,在貸款申請中增加一個語言變量是一個正確的方

向。




